
With reference to the items mentioned in Section 10B:

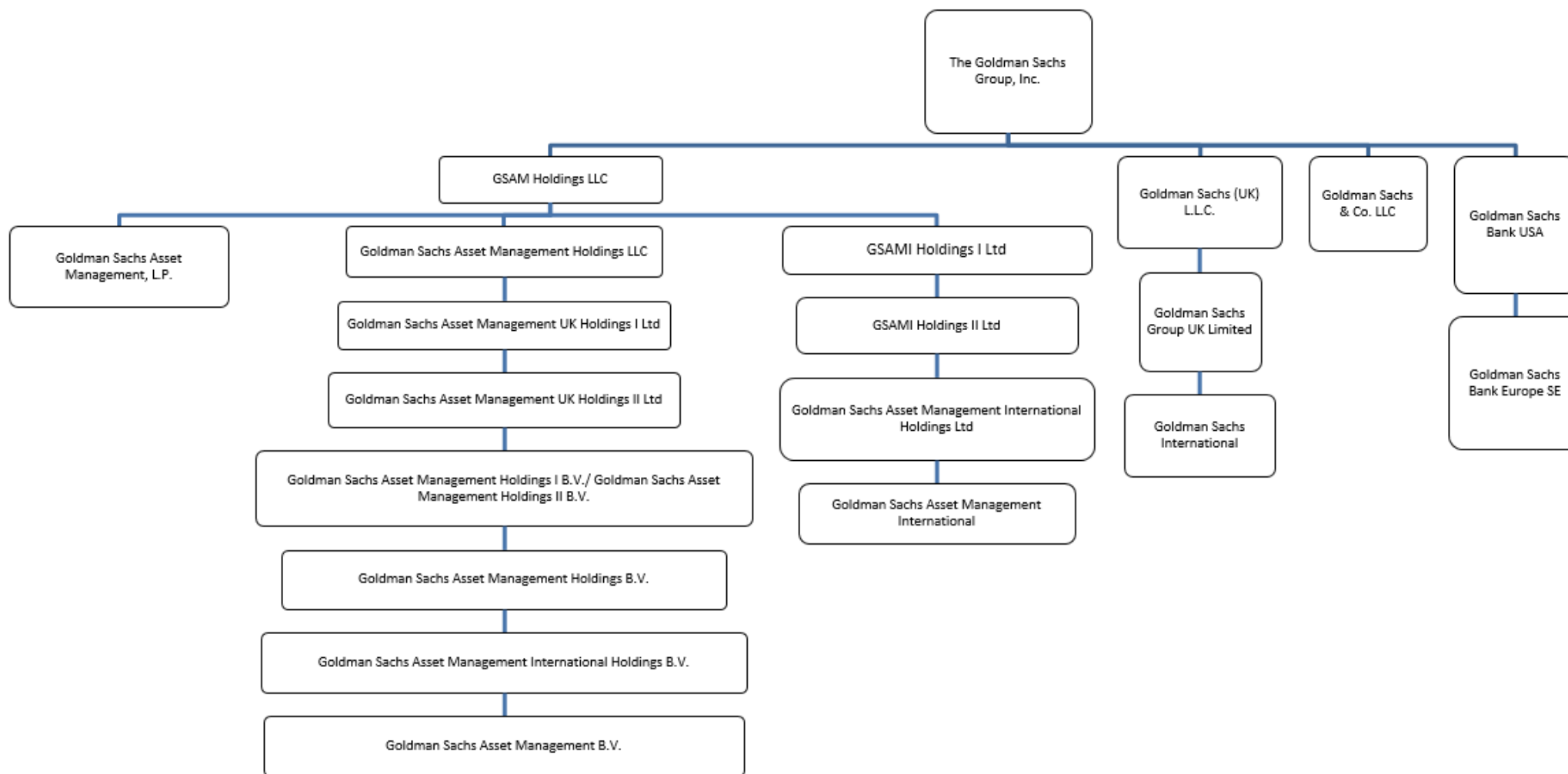
